
The company has 4 factories , 4 supply bases , more than 900 employees ,116 products and 31 business lines.

The Bureaucracy System

- 1 When it comes to work specialization, there are two options (the jobs are according to their specialization and experience, and they give training courses to expand the job cadre).
- 2 Hierarchical authority layers The position and the hierarchy are distributed based on experience and qualification, and the organization favors experience over academic qualification (with the exception that the person with the practical qualification attends rigorous training).
- 3- The formal choice In the case of operational departments, the company believes that the individual with experience has a higher qualification than the one with a scientific qualification, and it also calculates the cost and benefit, which means what is the collected in exchange for this decision, and the company encourages in the following scenarios: the supervisor for a period of not less than 8 years, and the head of the department for a period of not less than 12 years. There is no need for all those years of administrative experience.).

- 3. Hiring employees comes from the national corporation (government) not from the company, so they follow the hiring process of the national corporation.



The Functions of The Company

The Functions of The Company:





The batch process plant, which began operations in September 1992, is categorized as a batch process plant. It makes liquid specialty chemicals for oil well drilling, crude oil treatment, gas treatment plants, refineries, and a variety of other industries. It can also make chemicals for things like soap, detergent, paint, and colors, among other things. Depending on the required products, the typical annual productivity is around 5 000 000 liters.



Salt Plant

Produce crushed crude salt in 30 KG sacks for oil field application. 3/1992 was the start date. The highest annual output is 9000000 kg.



Specialty Chemical Services:

offers services for oil and gas treatment in industrial processes, including demulsifies, corrosion inhibitors. scale inhibitors, biocides, flow improvers, oxygen scavengers, and cooling water treatment.

The Functions of The Company:



Lost Circulation Materials

These compounds are mixed into drilling fluids to seal pores in permeable minimal Pressure formations and prevent drilling fluid from leaking into the formations. Mica, wood fiber, and crushed nut shells are examples. To ensure client pleasure, the product is packed in the right manner. Production began in January 1991, and the highest annual output is around 3000000 kilograms.



Drilling Fluids Engineering

Chemical and mud additives will be provided. Prepare a proposal for drilling wells based on geological reports for each well, as requested by the client.



Logging in The Mud

provides mud logging services include that real-time data capture and real - time analysis to detect hydrocarbons drilling mud and drill cuttings. drilling supervision, as well as a geologist on the wellsite.
